## **Our Projects**



British Columbia, Canada

The KSM Project is a proposed gold, copper, silver and molybdenum mine, located 65 km northwest of the town of Stewart, B.C. In 2014, the KSM Project received Environmental Assessment (EA) approval under the British Columbia EA Act, the Canadian EA Act (1992) and the Nisga'a Final Agreement. In 2020, Seabridge purchased the neighboring Snowfield Property (now called East Mitchell deposit) which could have a significant positive impact on the KSM Project economics.

Seabridge has entered into Impact Benefits Agreements with the Nisga'a Nation, Tahltan Nation, and signed a Gitanyow Wilp Sustainability Agreement. Seabridge also received letters of support from the Gitxsan Hereditary Chief's office for the KSM Project.



The Iskut Project was obtained upon Seabridge's acquisition of SnipGold Corp. in June 2016. The Project includes the former gold Johnny Mountain Mine and Bronson Slope deposit, located 110 km northwest of Stewart, B.C. Detailed environmental remediation is being done on site and exploration drilling started in 2017.

# **3** COURAGEOUS LAKE

Northwest Territories, Canada

The Courageous Lake Project is located 240 km northeast of Yellowknife. The Project covers almost all of the 53 km long Matthews Lake Greenstone Belt, which historically hosted two high-grade gold mines and has gold showings all along its length. Seabridge plans to grow the estimated resource base with additional drill programs to identify higher grade zones and new deposits.

Nevada, United States

The Snowstorm Project consists of 31 square miles of land holdings strategically located at the projected intersection of three of the most important gold trends in Northern Nevada: the Carlin Trend, the Getchell Trend and the Northern Nevada Rift Zone.

In August 2019, Seabridge acquired the neighbouring Goldstorm Project consisting of 134 mining claims and 1,160 leased acres (totalling approximately 3,900 acres or 15.9 km²) located about 3 km to the east of the Snowstorm Property.



The 3 Aces Gold Project was acquired by Seabridge in May 2020 from Golden Predator Mining Corp. Located in the southeast of Yukon, Canada, the Project covers approximately 350 square kilometres on the eastern margin of the Selwyn Basin, which hosts several larger base metal deposits, including Howard's Pass. Exploration drilling began at 3 Aces in 2021.

At Seabridge Gold, being a responsible and welcome member of the communities in which we operate is an essential part of our business strategy.





# Community

Seabridge is dedicated to establishing strong relationships with the communities surrounding our projects. We believe it is important that Indigenous and non-Indigenous people living in the project area are engaged and have their voices heard.
